5.1 President: Paul Duncan

- 5.1.1 Welcome everyone, congratulations on a great season, and thank you board members for hard work making lots of positive changes, organizing events, and putting money in the bank
- 5.1.2 It was a good season, despite the January interruption (Government shutdown)
- 5.1.3 No LMHA teams made it to the OMHA Finals and 1 LMHA team made it to the TCHL Championship
- 5.1.4 1st LMHA Golf Tournament a success and registration now open for the June 25th event

5.2 1st Vice President (Rep/OMHA): Casey Deschamps

- 5.2.1 U7 age division chose not to travel and opted out of TCHL
- 5.2.2 Partnership amount remains in the budget and be accounted for with any partnership. Previously turned down by OMHA because there was not a large enough membership to form an A centre.

5.3 Treasurer: Jessica Dagg

- 5.3.1 Budget Review: Projected \$65k budget, January 2022's refunds were reflected as a reduction of registration fees, money has been allocated for Development, ice rentals continue to be most significant costs, reduced locker rentals by downsizing space used.
- 5.3.2 Registration 2022-2023: No increase in registration fees. U5 and U7 fees reduced from the previous season while U9 through U18 fees remain unchanged from the previous season.
- 5.3.3 Fundraising was the highest ever, thank you to everyone involved. (Casey)
- 5.3.4 Need to maintain surplus. Organizations may run with 1 year of operating expenses in their bank account. This includes consolidated LMHA accounts and Hockey for All Fund. (Paul)
